### The internally displaced persons living in Megiashi's Shelter <u>Centre на Meѓаши, after 5 vears have returned to their homes</u>

The four families living in Megjashi's Shelter Centre have finally returned to their homes after a period of five years. The families have been living in Shelter in order to avoid the horror resulting from the conflict in the year 2001, on which they were immediate witnesses in their native Arachinovo. Eight of the displaced persons were

children, three of witch born in the Shelter Centre. During the summer the families moved to their new homes in Skopje and Kumanovo and are gradually adjusting to the local life. Ivana and Sanela enrolled in high schools, Andri-Jana and Marija entered new primary schools, Jovana enrolled a primary school for the first

time, while Ace, Nikola and Marija will start to go to school from next year. We wish them luck!

# Forum Theatre for the Life Stories of the children without parents who lived in Homes or foster-families



The First Children's Embassy in the World- Megjashi almost one year already, is providing psycho-social and educational support to 17 children without parents, who have left the Home "11 Octoher".

Our goal is to contribute in the socialization and the independence of the youth from the

Home "11 October" and the foster families, after they leave them, through educative workshops and counseling workshops for psycho-social support.

### Over 250 million children in the world are victims of abuse of child labor

At the 12 of June celebrating the International day against abuse of children's labor, Megjashi made an press release addressed to the public alarming the increasing number of children in Macedonia whose labor is being abused.

Moreover, we reminded the public that although Macedonia ratified the Convention against abuse of children's labor four years ago, the situation is alarming.

Very disturbing is also the fact that in Macedonia more than 18000 children are not included in the

educational process and more than 1000 children are homeless.

In the world there are 250 million people whose labor is being abused. Only in India this number is between 60 and 115.



# In Macedonia, there are 726 internally displaced persons, 177 of which are children

At the 20 of June celebrating the **International day of refugees** we reminded the public that in Macedonia during the year 2006, 2473 people asked for shelter, 2032 of witch came from Kosovo as result from the crisis in Yugoslavia in 1999. In Macedonia there are 726 resettled people, 177

of witch are children, as result from the conflict in 2001. Half of them live in families, half in camps.

There are 50 million people in the world described as victims of forced resettlement.14 million people are refugees-in conventional sense of the word-people that

abandoned their home or country in order to avoid exile, violence or armed conflict. More than half of the official numbers are children Activities of the Social service—helping the socially endangered children and families.

We inform all citizens that in case they have food, clothes or shoes they would like to donate, they can do that in our office.

# Petition against the legalization of the Party Brotherly Love, Freedom and Diversity

On July 19. immediately after the news the Court in the Netherlands legalized the Party "Brotherly love, freedom and diversity", the Embassy Megjashi sent and appeal for signing of the petition.

Reaction regarding the legalization of the political party "Brotherly love, freedom and diversity" by the Court in the Netherlands

The First Children's Embassy in the World- Megjashi, as a international NGO for protection of children's rights, reckons that the legalization of a Party which represents pedophile's interests implicates danger to the safety of the society, and especially to the safety of the children.

The Embassy Megjashi considers that the program goals of this Party which support lowering the legal age for sexual intercourse, legalization of child pornography, even legal display and promotion of violent pornography contradicts to the spirit of the Convention for children's rights.

Namely, the signatories of the Convention are obligated to stand for international action of the countries and the other international organizations on behalf harmonious development of child's personality, growth in a family environment, with love and understanding.

Also, the plead of the Party for enabling children on the age of sixteen to prostitute themselves and to appear in pornographic movies contradicts with the Convention for prohibition of worst forms of child's labor abuse, No. 182 brought on the convention of the International Labor Organization. It was ratified by the Netherlands on 14.02.2002.

The Convention was so far ratified by 161 countries, and Republic of Macedonia has ratified it on 30.05.2002 as a result of the lobbying of the First Children's Embassy in the World- Megjashi as well. In this Convention under article 3, the use, production and involving children in prostitution due to production of pornography is defined as one of the most dangerous forms of abuse of child's labor.

The First Children's Embassy in the World- Megjashi supports the Dutch organization for protection of children - Foundation Profit for the

World's Children and their action of gathering signatures on petition for ban of this Party.

We would like to emphasize that the registration of this Party contradicts **article 3** from the Convention of children's rights, which states: In all activities regarding the children, children's interest are of primary importance, no matter whether they are administered by the public or the private Institutions for social welfare, the Courts, the administrative bodies or the legal institutions.

Therefore, we think that the Government of Netherlands should keep their "doors closed" facing manipulation of children's rights and should not allow legalization of one of the most dangerous acts on the children's rights ( sexual abuse/ Pedophilia), which is directly connected with abuse, and has very little to do with sexual freedom!

Within the frames of the MCP program, Megjashi is coordinator of the "program for dialogue and cooperation with the civil organizations, the government, the business sector, the media and the public".

# Over 100 children are using the services of the Children's Workshops in Megiashi!!

Our popular **Children's Workshops** this year have new,



richer program in new classrooms at the same address. The new capacity provides membership for 450

children at the age of 4-15. Over 100 children are using the services of the children's workshops for a month till now.

Each workshop begins with short exercise for non-violent communication where children learn to develop their spirit of friendship and solidarity. Then, on creative way with short pauses the new material is acquired. One workshop lasts 90 minutes and is led by a trained volunteer.

Megjashi's workshops are the following: English, German, Greece, French and Albanian languages; Computers, Mathematics,

Astronomy, Sports, Origami, Good Health, Ecology, Good Manners ,Art, Theatre, Literature, Geography, Fashion, Education for human values and philately.

All children's workshops are divided on two age groups: 4-9 and 10-15 years and have their own time schedule. The groups are also divided according to level of knowledge on basic and intermediate.

The price for **one year membership is 600 denars** and can be paid on 2 rates -300 This year part of the necessary funds is provided by Australian embassy in Belgrade.

The workshops are still open for new members, every day from 08 to 20h on the telephone number: 2463 -900; 2465-316.

### Political abuse of children in the Republic of Macedonia

During the election campaign we've sent a reminder to all media not to abuse children for political purposes.

We have reminded that according to the Convention for Children's Rights and the Law for Child Protection "Child abuse for political or religious organization and action is forbidden." (Article 9/12).

It is forbidden by law during the political campaign, the political parties to include children in their electoral campaigns – for promoting materials, in video clips, billboards, attending meetings, recruiting in the political youth membership, agitating etc.

Economic exploitation on all people under the age of 18 for sticking posters, handing flyers, t-shirts etc is forbidden as well.

We have also encouraged the political parties to have pre-electoral contest with content in their platform that would make the childhood careless and secure, and at the same time would guarantee implementation of the Convention for Children' Rights and would aim at avoiding of children's rights violation.

We have recorded on our SOS line a report of political abuse on a group of children in Bitola.

> they shared with us unselfishly and faithfully and courageously opened themselves up in front of the public and talked about their pain.

Many of them have had a horrible past that they find extremely hard to talk about. But not all stories are sad,

in some of them the young people are very grateful and

pleasantly talk about their surrogate parents that have raised them as their own children.

The idea with the forum was to reach the authorities at least a bit, to those whose hands hold these children's futures and to the wide public.

# Mutual reaction of the First Children's Embassy in the World-Megjashi and the Helsinki Committee for Human Rights of R.M.

The First Children's Embassy in the World – Megjashi and the Helsinki Committee for Human Rights of the Republic of Macedonia reacted upon the report "Sexual harassment on his own three daughters" broadcasted on A1 Television on Saturday, June 24, 2006, by the news reporter Mare Stoilova.

Two of the daughters were interviewed in the report who witnessed the incest conducted by their father to three of their sisters. One of the witnesses was the daughter who managed to escape the sexual harassment by her father, and unfortunately, the journalist ethics was not followed in this kind of circumstances, as to protect the child's identity by shading the face or mutating the voice.

Four months ago we sent an appeal to all media to respect the privacy, identity and integrity when reporting incidents about children. In our opinion the children should be encouraged to talk about violence in order to be able to recognize it, but the media should record any reports professionally, with all the necessary protective and technical means that guarantee the privacy and the protection of the child's identity and integrity. With this kind of approach the media can contribute a lot to the documentation of violence, its prevention and to be partners with the citizens' organizations that are fighting for protection and respect of the children's rights.

Once again we state our readiness to cooperate with You especially in similar cases, exclusively for the benefit of the children we are willing to plead with you in the future, when broadcasting children's statements, to use the necessary protective methods. It is undisputable that despite of our mutual best intention, children's integrity can be easily harmed which can be even more stigmatized and victimized.

For this reason, we kindly remind you of:

#### Article 3 of the Children's Rights Convention

In all activities related to children, the child's interest is of primary significance, regardless of whether they are conducted by the public or private institutions for social protection, the courts, the administrative organs or judicial entities.

#### Article 16 of the Children's Rights Convention

No child should be exposed to any deliberate or unlawful interference in its privacy, family, home or personal statement, or to any unlawful insults of hits reputation or honor.

The child has the right to legal protection against any kind of interference or insults.

# Article 23 of the Children's Rights Convention

The member-countries admit that children with physical or mental disabilities should be enabled to live an entirely respectful life, in conditions that reassure its dignity, encourage individuality and relieve the active participation in the community.

The basic manuals and principles of the International Federation of journalists informing on issues related to children are:

- to carefully take into consideration the consequences of publishing of all kinds of material related to children, thus reducing any harm upon children;
- to avoid using any visual or other kinds of identification of the children unless it is necessary for the public;
- to ensure independent verification of any information given by the children and to take special care that the verifying process does not endanger the children who gave the information:

- to use honest, open and straightforward methods for providing images and if possible, to obtain them with the knowledge and approval by the children or the adult responsible for the children.

The media should not only consider and inform about the children's condition simply as an incident, but should constantly report on the process that may lead or may have led to the incident.

It is in the children's best interest to be constantly aware of such detail that may have a negative effect on the children, whom we strive so hard to protect.



# SOS help line for children and youth 0800 1 2222—free line

During the period between July and October, a total of 193 children and young people found courage to ask for help at SOS line for children and youth **0800 1 2222**, out of which 37 were boys, and 151 were girls, 21 of the total calls were related to physical or sexual harassment, and 2 of the calls have reported pedophilia.

Since September, the exterior supervision on the work of the volunteers at the SOS line, by our long term partner Stanislav Petkovski.

Also additional training for the volunteers has been provided, which will help the quality of their work.

The SOS line has financially been supported by the Macedonian Telecommunications and the Agricultural Bank. A part of the costs for the volunteers are covered by Pexim Computers and the SOS line from Ireland.

# Free Legal Service free legal advice

In the last 4 months, the Leal Service has reacted upon 14 newly reported cases of Children's Rights violation

"Call upon your rights"

In cooperation with the SOS line, the **free legal service** operates actively.

In our work we call upon the protection of the children's rights according to the International Conventions for protection of the children's rights and the laws of the Republic of Macedonia. This also includes the Convention for children's rights of the UN, the Convention for prohibiting of the worst kinds of child labor at MOT (Youth Open Theater), the Law for child protection, the Family Law and other related to the field of children's rights.

The legal service is constantly in touch with other civil organizations and state institutions for a more successful protection of the children's rights.

The most frequent contacts are those with the Legal State defender.

# Part of the cases of violations of children's rights

- 1. Case of neglecting a child. The case was reported by the uncle of the minor (15-yearsold). He reported that the minor is living with his mother in atypical living conditions, and there are serious indications that the mother is working as a prostitute, and is not paying attention to the child's psychosocial development which doesn't go to high school and has unhealthy social life.We reported this case in the Center for Social Work, where a process for supervision for parental right has begun. The CSW investigated the case i continued to follow it. According to them, positive results in the minor are noticeable.
- 2. Case of prostitution of minors by an older person. The case has been reported in the Ministry of Internal Affairs, who started an investigation. In the interest of the investigation, more details in the following issue.
- **3.** Case of physical violence on children by their professor in Home for children. The Case was reported in MIA, and we have reported it to the Ombudsman and the CSW. CSW pleaded out of jurisdiction since the children are not their users. There is an process in progress for another CSW.
- 4. Case of physical and psychological violence over a student by the teacher in a elementary school. For this case we have informed the Ombudsman which by legal duty collected opinions from the Principal of the School. On request of the Principal, there were conversations between the teacher, the child, the parents and the Psychologist of the school. According the information of the Ombudsman, the conversations contributed towards the relation teacher-students. The Embassy just started an initiative for penalty of the teacher.

# International Conference of the children's SOS help lines, organized by Child Helpline International and Briss -Sweden

From 1st to 4th October, in Stockholm was held the third International Conference of the SOS child help lines from all over the world, organized by the Swedish Queen Silvia.

Among the representatives of the SOS help lines, on this conference also participated representatives of the International Union of Telecommunications which are the mostly sponsoring the SOS help lines. Through workshops, in this conference among the other were promoted innovations in the work of the SOS help lines

such as: support/talk over SMS, over e-mail, over web-chat, as well as special interactive portals "From children for children", where the children ask a question for a problem and talk with the operator over e-mail.

On this conference also participated our SOS helpline 0800 1 22 22, represented by Mrs. Gordana Pirkovska-Zmijanac – Program Manager in the Embassy Megjashi. Our Help line received a special certificate that is striving to achieve the world standards of

the work of SOS help lines.

"It is praising how the modern technologies are helping the work of the SOS help lines. It is a challenge our SOS help line to start working this way." said Mrs. Gordana after she returned.

# "Together for Transparency"

The Civic society is effective only if it is approved and enrooted in the society and the public. This means responsibility, and transparency in front of the public , especially for those organization which are of public interest.

With the aim to give contribution towards the transparency in the work of the Civic organizations, as a contribution towards improving the effectiveness of the civic sector, a group of Civic organizations, 8 member of the Civic Platform

of Macedonia, decided for the third time, voluntarily, to publish their Financial Reports, including the Independent Audit Reports: the First Children's Embassy in the World- Megjashi, Macedonian development foundation of the firms (MRFP); Macedonian center for international Cooperation (MCMS): Postpolio group for support Polio Plus, Association of organizations of Women in Macedonia (SOZM); Center for Civic Initiatives (CGI) Prilep; Movement of the Ecologists in Macedonia, Association of Democratic Initiatives (ADI) and the Youth Cultural center (MKC) Bitola.

The Annual Reports were published on 01. August 2006, in the papers Dnevnik and Facti.
